New PAMET Charter Gets 100% Approval

After three years of extensive review and consultation with chapter, regional and national officers which started in 2015, the 2017 Constitution and By-laws of the association was finally ratified on November 22, 2017, during the 53rd PAMET Annual Convention at Marriott Grand Ballroom, Newport City, Pasay City.

An overwhelming 100 percent approval was given by the qualified members who voted using the automated system adopted by PAMET. It took effect 30 days after ratification.

In compliance with the constitutional requirements, copies of the final version of said charter were distributed to the different Chapters and members prior to Mid-Convention in Iloilo City in May 2017, wherein initial ratification was held. It was also posted in PAMET website and social media accounts in order to disseminate it widely to the general membership.

The initiative to ratify new by-laws was brought about by some provisions in 2008 version that need updating and clarification. There were also additional parts introduced in order to address the needs of the times. Among them were the provisions on the creation of International Chapters and Institutional Units, allocation of 1 slot to those coming from the Chapters who want to run to be a member of the National Board and the creation of Northern and Mindanao Regions. Other salient parts are matters concerning membership, welfare and benefits and ethics.

The committee on Constitution and By-laws is chaired by PAMET Exec. Sec. Gina Noble while the committee on Election is chaired by Ms. Jacinta Cruz.

framework prepared by the team for discussing cases involving issues. This is the procedure on how to handle ethical dilemma:

- 1. Facts of the case
- 2. Central ethical problem
- 3. Practical questions
- Definition of terms
- 5. Moral principles/ Virtues involved
- 6. Resolving conflicts
- Recommendations

To give insights on how to handle a situation, each group was given a case to resolve. The following is an example of the case presentation.

- 1. Facts of the case
 - Rose became a Medical Technologist through the support of her Aunt who used to be a Section Supervisor
 - The owner of the R.A.Y Inc is the best friend of her aunt
 - · The clinic where Rose is working wanted to upgrade some diagnostic equipment. There were three supplier who were called for demonstration
 - Rose being the Section Supervisor in one of the persons to give the evaluation of the equipment to be purchased
 - · Rose' aunt wanted her to give favorable evaluation in favor of R.A.Y. Inc even if the said company cannot meet the calibration requirements and the high cost of reagents.
- 2. Central Ethical Problem Rose is torn between giving in to the request of her aunt and giving an objective evaluation
- 3. Practical questions
 - Is there a moral obligation on the



part of Rose to return the favor to her aunt by giving a favorable evaluation to R.A.Y. Inc?

- What will be compromised should Rose recommend R.A.Y. Inc?
- Are the other two suppliers better than R.A.Y. Inc?
- 4. Moral Principles/Virtues Involved
 - Utang na loob
 - Personal interest versus common good
 - · Conflict of interest
 - Independence/autonomy
 - Justice/fairness
 - Quality service
- 5. Resolving conflicts

Utilitarian (based on utilitarian ethics Rose should not recommend R.A.Y. Inc. Pros: objective evaluation, quality service on timeliness and cost effectivity, more qualified supplier Cons: possible strained relationship between Rose and her aunt Kantian (if Rose chooses the favor being

dictated by her aunt)

Pros: Strengthened relationship between Rose and her Aunt Cons: Rose integrity will be compromised

Violation of code of ethics of medical technologists which uphold the dignity and respect of the profession

and conduct oneself with reputation of reliability, honesty and integrity

- 6. Recommendations:
- Make a criteria rubrics for objective evaluation
- · Rose can delegate the task to another person to avoid conflict of interest
- · Rose may inhibit in the evaluation since the owner/ supplier to be evaluated is the best friend of her aunt.

The objective of the program is to apply the concept of standards of personal and professional ethical programs in health care. It should develop a culture that creates and supports an environment that fosters teamwork, emphasizes quality, recognizes the customer and promotes learning.

The 5-woman team is composed of Dr. Lilibeth Tanchoco, Dean College of Medicine, Manila Central University, Dr. Cynthia Fabian-dela Rea, Diabetologist, Valenzuela City Emergency Hospital, Dr. Regina Sanchez-Ampil, Nephrologist, National Kidney and Transplant Institute, Dr. Trigidia de Vera-Alvega, Pediatrician. Valenzuela Citicare Hospital and Sis. Cecille Asuncion Cabahug, a BS Pharmacy graduate of University of Santo Tomas, Director Administrative Services of De La Salle University Medical Center.

The 30 delegation of this workshop came from various laboratories in hospitals and institutional units, deans and faculty members of Medical Technology schools.

He was cited for having contributed in the upliftment and advancement of Medical Technology profession particularly through research works. He authored a research study published in International Journal of Bacteriology, entitled "Review on the Antimicrobial Resistance of Pathogens from Tracheal and Endotracheal Aspirates of Patients with Clinical Manifestations of Pneumonia in Bacolod City in 2013".
